# January 2019 Release Overview of Key Changes

The USPS filed notice with the Postal Regulatory Commission (PRC) for price changes to take effect 1/27/2019. In addition to price changes, the notice includes structure changes, postage statement updates, and technical specification updates.



## **JANUARY 2019 PRICE CHANGE UPDATES:**

The Postal Service approved a price change effective January 27, 2019, which will affect all mail classes and special services. A complete list of the price changes are noted in the Notice 123, <a href="https://pe.usps.com/PriceChange/Index">https://pe.usps.com/PriceChange/Index</a>. The implementation of Dimensional weight pricing to all zones for Priority Mail, Priority Mail Express and Parcel Select has been deferred and will become effective June 23, 2019. Balloon rate pricing for Priority Mail and Parcel Select has been eliminated effective January 27, 2019.

The price change applies to all hardcopy postage statements, <u>https://pe.usps.com/PriceChange/Index</u>, and electronic file submissions, including Shipping Services Files (SSF), mail.dat and mail.XML. ## FIRST-CLASS PACKAGE SERVICES (FCPS):

On January 27, 2019 FCPS will change from a weight based pricing structure to a zone and weight based pricing structure. Table 1 below shows the pre 1/27/19 Notice 123 based on weight based pricing (in ounces). Table 2 below shows the effective 1/27/19 Notice 123 pricing based on weight and zones. Postal zones are based on the distance a package travels from origin to destination.
